Last date for proposals to be submitted in India: May 31, 2010

Under the Agreement of Cooperation in Science & Technology concluded between Government of India and the Government of Norway, the Department of Science and Technology (**DST**) of the Government of India and the Research Council of Norway (**RCN**) have started a programme for joint funding of Indian-Norwegian joint research projects in mutually agreed fields to achieve world-class scientific results. Norwegian funding is part of the RCN **INDNOR** research programme.

DST and RCN invite Indian and Norwegian scientists / researchers to submit proposals for cooperative research projects in the research field described below. The proposed collaboration should build on and strengthen already on-going research activities in each research group and contribute significant added value to these. Allocations will be based on scientific quality.

RESEARCH AREAS COVERED

Initially the following broad areas are covered in the Programme:

- Climate research including CCS (carbon capture and storage)
- Renewable energy including solar energy
- Geotechnology and early warning systems for geohazards;
- Nano-science/ technology related to renewable energy

KIND OF FINANCIAL SUPPORT AVAILABLE

Support is available for cooperative research projects including project related visits of Indian and Norwegian researchers to the counterpart country. The cooperative research period shall be 3 years. As the main objective of the Programme is to promote collaboration between Indian and Norwegian scientists, funding will preliminary be for exchange visits of scientists. To facilitate the objective of the Project, incremental funding towards of up to 2 research personnel (at doctorate/ post-doctorate level), consumables, project related workshop/ discussion meeting and contingencies may also be supported based on the funding agencies (DST/RCN) assessment of the proposals.

PROPOSAL SUBMISSION

Indian and Norwegian applicants shall submit applications in English to DST (by 31st May 2010) and RCN (by 21st April 2010), respectively.

For Indian applicants the Application forms and Guidelines may be downloaded from www.dst.gov.in and one original plus four hard copies (by post through proper channels) and one soft copy (through e mail and CD) are required to be submitted to:
